FINANCIAL REPORT

Joe Hughes, Budget Officer, presented the Financial Report for revenue received during the month of November 2017: \$ 420,244 to the General Fund; \$39,733 in the Motor Fuel Tax Fund; \$ 213,144 in the Sewer Fund; \$ 84,853 in the Business District; and \$ 6,312 in the TIF District for a combined total of \$ 794,286. The fund balances at the end of November 2017 were: \$ 8,091,258 in the General Fund; \$ 1,116,867 in the Motor Fuel Tax Fund; \$ 4,043,399 in the Sewer Fund; \$ 3,804,734 in the Business District; and \$ 116,319 in the TIF District for a combined total of \$ 17,172,577.
