PRESENTATION: GODFREY FIRE PROTECTION DISTRICT

Chief Eric Kambarian, Captain Jacob Ringering and Terry Ford, Treasurer of the Godfrey Fire Protection District Board presented the proposal for funding for the Department for assistance to replace aging pumpers and equipment and annual recurring funding for one career firefighter. The cost of replacement truck would be around \$300,000 basic and \$380,000 for equipped truck.

Chief Kambarian reported that the funding from the referendum was used to keep two pay staff positions from layoff.
