Trustee Springman asked the question on when was the Village approached for the sale of the Sewer System? Mayor McCormick reported that in 2016 he met the Susan Story, President and Chief Executive Officer of American Water and he suggested to her that they purchase the sewer system. Trustee Springman suggested that the Village not go out for RFP for the system before doing a Rate Study for Users Fees increases. Trustee Weber reported that the Village will not be able to get out of violations with the Illinois EPA. They will continue adding projects for repair or replacement. The Village is just going out at this time for RFP to find out what the system is worth. Trustee Schrumpf reported that he felt the Village can operate the system more efficient than American Water or any other private companies, as they have stockholders who will require a return on their stocks. Trustee Stewart also suggested that the RFP would allow the Village to determine if the sale of the system would be in the best interest of the users and residents of Godfrey.
