CONSIDERATION OF TOWNSHIP ABOLISHING PUBLIC HEARING REQUIREMENTS

Supervisor Seymour reported that the Village Board of Trustees has requested that the Township also consider holding a Public Hearing for the Consideration of Abolishing the Godfrey Township on April 3, 2018 before the meeting. Mark Stewart moved to give authorization to Clerk Whisler to publish notice for a Public Hearing on April 3, 2018 at 6:00 p.m. for the Consideration of Abolishing the Godfrey Township, seconded by Joe Springman. CONSIDERATION OF FY2019 BUDGET AUTHORIZATION

Supervisor Seymour presented the FY2019 Budget for the Board to review. Supervisor Seymour presented the FY2019 Budget and Appropriation Ordinance. The total proposed appropriations are \$281,965. Joe Springman asked if the Township was budgeting enough funding for the Contract Service – Quadrennial Assessment for 2019. The County has notified the Township of the increase of assessment charges of \$28.10 per parcel for 8585 parcels at a total cost of \$241,238.50. Monica Jerrells, Assessor, reported that based on the information she was given from the County she budgeted for \$89,000 and did not receive the memo until after budget was turned in. Supervisor Seymour reported that any charges not paid will be transferred to the Village after the abolishing of the Township. Clerk Whisler reported that the Township will need to hold a public hearing before approval of the budget. Mark Stewart moved to hold the public hearing for the Township budget on March 6, 2018 at 6:14 p.m., seconded by Joe Springman. Poll of Board: Ayes-6, Nays-0, Absent-1. Motion carried.

PUBLIC COMMENTS

Monica Jerrells, Assessor reported that the County is raising the assessment rates only because of the Alton and Godfrey consideration to abolishing the townships.
