FY2018 AUDIT REPORT PRESENTATION

Supervisor Seymour reported that Stacey Eccles, Hughes, Cameron & Company, LLC of Godfrey presented the 2017-2018 Township Audit report. Township Fund balances as of March 31, 2018:

The Township's total expenditures exceeded total revenues, on the modified cash basis of accounting, by \$2,760 for the year, resulting in an increase in total net position of 1 percent over the previous year.

The Township's General Fund ended the year with a fund balance of \$164,028, which represents 107 percent of recurring revenue of the fund and 98 percent of recurring expense of the fund. The General Assistance Fund had a fund balance of \$94,474, which represents 133 percent of recurring revenue of the fund and 178 percent of recurring expense of the fund.

The Estimated Quadrennial Reassessment that was given was \$180.791 payable in four installations for 2018.

Township Net Pension Liability current Single Discount Rate assumption at 7.50% would be \$85,159.

Supervisor Seymour placed the 2016-2017 Township Audit on file in the Clerk's Office.
