Introduction to the MS4 Program

In 2003 Madison County and its urbanized areas were included in the second phase of the EPA's Clean Water Act. We organized the original Madison County MS4 (Municipal Separate Storm Sewer Systems) Co-Permittee Group shortly thereafter.

Our goal was to combine our resources to address the six (6) minimum control measures required to regulate non-point source pollution:

- 1.) Public Education & Outreach
- 2.) Public Participation & Involvement
- 3.) Illicit Discharge Detection & Elimination
- 4.) Construction Site Runoff Control
- 5.) Post-Construction Runoff Control
- 6.) Pollution Prevention/Good Housekeeping.

Clean water is an essential resource for every community and resident. The goal of the MS4 program is to promote positive activities and provide resources and education to help keep water bodies clean for drinking water, recreation, wildlife habitat and aesthetic value.

Partnering with communities, municipalities and universities within Madison County, the Co-Permittee



Group is able to pool resources and share experiences to support compliance with the EPA requirements for the benefit of all within the County.

Village of Godfrey's Park Department "Memorial" Trees for the 21st Arbor Day

On April 26, 2019, 26 total trees were planted and dedicated at Glazebrook Park, LaVista Park and Hoffman Gardens. Over 300 saplings were provided to those in attendance.

Nature Institute 8th Annual Riverbend Earth Day Festival

On April 13, 2019, local entertainment, food and drinks, an artisan's market, environmental education and more was presented at this annual festival. The festival is free and open to the public. It featured nature activities and information from a variety of environmental nonprofits. Educational animal presentation was given by Serengeti Steve and TreeHouse Wildlife Center.
