It is fairly common to receive requests about available properties or sites for business locations. When these inquiries occur, the lead

Maintaining An Inventory Of Available Commercial Properties

time for response is usually limited - sometimes a matter of only a few days. Given the importance of a quick reply, it becomes necessary to identify available property and related information ahead of time.

The type of information requested in these in-

- the availability of the property,
- the size and type of any of structures
- utilities,
- Zoning,
- whether or not the property is eligible for any business incentives offered by local or state government; and,
- pricing.

Godfrey's Office of Economic Development maintains a list of known available properties not on public listings. For example, the list may have properties in which the owner would entertain selling if an opportunity were to arise — but there is no active attempt to sell.

Identifying available properties includes monitoring the websites of local real estate offices, and other platforms that have property listings. It also requires quite a bit of networking and phone calls to property owners in order to identify sites that might be available.






Often times we complain about property taxes being so excessive. It probably is a safe assumption

that nobody really enjoys paying taxes. Without getting into the debate of whether taxes are too expensive, or not, it might be beneficial to review



### **Percentage of Total Property Tax Bill**




how the Village of Godfrey property tax compares to surrounding communities and how those tax dollars are allocated across the various taxing bodies within the community.

First, let's look at how Godfrey's total property tax rate compares to nine surrounding communities. Godfrey's "Property Tax Rate" is 7.863%. We see that Godfrey ranks third, with Roxana being the lowest at 6.484% and East Alton the highest at 11.635%. It should be noted that Roxana and

Wood River have the refineries generating hundreds of thousands in tax revenues.

Just looking at the total tax rates of the different communities does not really tell the full story. If we look at the percentage of the total tax bill that goes to the actual municipality, we begin to gain some insight as to how much money is actually generated for operations. When comparing Godfrey with the same set of communities, we see that Godfrey is the second lowest at 1.7%. That means that less than \$.02 of every property tax dollar goes to the Village. The only municipality that is lower is Foster Township.

Let us take a look at how tax dollars are allocated across the tax-



ing bodies within the Village of Godfrey. Most notably is the Alton School district takes almost \$.68 of every property tax dollar paid. The second highest user of property tax is the Godfrey Fire Protection District at \$.095 of every tax dollar. Following the fire district is Lewis and Clark Community College, Madison County, and the Hayner Library District. Lastly, the Village only takes \$.017 of dollar of property tax.

Although not outlined in this article, many of the surrounding communities have additional taxing bodies that Godfrey does not have. Many communities have additional road and bridge districts, airports, and other townships. By contrast, Godfrey takes care of all roads and streets through it's general fund that is generated by taking just \$.017 on every property tax dollar paid, along with a motor fuel tax that is collected by the State of Illinois. Godfrey also eliminated the Godfrey Township some time ago.

Finally, looking at an example of an actual tax bill shows that of a total property tax amount of \$3,418.16 the allocation that goes to the Village of Godfrey is only \$58.25.

The Mayor, the Trustees and the staff work to maintain effective and efficient operations within the Village. With the amount of property tax allocation that actually goes to the Village of Godfrey, its fiscal position is extremely sound. It has no debt and maintains an approximate \$1M balance in the general fund. In addition to the resources of the general fund, there are also dollars in the TIF District, the

Business District and Motor Fuel Tax accounts that are utilized to fund village operations.

According to Mister Donut's website, there are 5500 stores. However; here in Godfrey, we have the only one in the United States!

Mister Donut was established in 1955. In the early 1990's, Mister Donut was bought out by Dunkin' Donuts. All Mister Donut owners were given the option to become a Dunkin' Donut or become an independent. Over time, the Godfrey operation is the only one left in the United Sates.

Mister Donut has vast operations in Asia, particular in Japan where stores are numerous. The concentration of Mister Donut in Japan is somewhat like Starbucks here in the United States.

There's the story about a family from Japan flying into LAX and rented a car to drive to New York. They actually made a

point to stop at Godfrey's Mister Donut and take pictures.

The Godfrey store was opened in 1980 at it's current location by Godfrey businessman, Fred Tieman. On September 1, 2004, the store was purchase by current owner Caesar Blanco.

Mr. Blanco had retired from the Navy after twenty-six years of service and reached the rank of Senior Chief. He found that "retirement" did not work for him and was becoming bored. In a turn of events, he found out the current owners of Mister Donut would be willing to sell the business. After a couple of conversations, the deal sealed with a hand shake.

When Mr. Blanco purchased Mister Donut, there were eleven employees. The current employment level is twenty-two. Caesar indicated that over this eighteen years over ownership, all 6 of his children have worked at the store at one time or another. A daughter is currently working in the operation.

A unique feature is the amount of product variety. "We have over fifty-three different donuts. Other shops don't offer that selection," said Caesar. Additionally, they offer various breakfast sandwiches and tasty biscuits and gravy.

A typical day in operations begins with the donut "makers" starting at 5:00 p.m.

These employees are responsible for starting the process of mixing the dough and 'hand making' the donut varieties. At 12:30 a.m. the "finishers" come in and begin the process of icing, sorting and getting the products ready for sale. The delivery vans head out at around 4:15. One van goes north as far as Carrollton and one goes south as far as Granite City. Of course sending vans out at that time does have its risks. "One time we lost three vans in a four month period because of hitting deer," said Caesar.

Mister Donut is open seven day a week from 4:00 a.m. to 1:00 p.m.

Although I 'know' it was established in 1980, I cannot recall when it wasn't around. I remember 'back in the day' stopping at night after a band job to grab a coffee and a donut on the way home. Of course, now if I just look at a donut, it adds two pounds! But, thank you Mister Donut for being part of our small town.

Anyway, as the song says, "all my friends are from small towns....."
