As indicated in the May issue of "The Villager," a field research hotel evaluation report has been prepared for the Village of Godfrey for the potential development of a midscale to upper midscale limited-service style hotel in Godfrey, Illinois. According to the study, it is feasible for Godfrey to support an 80 room combination hotel.

The simple fact is that bringing a hotel into the community will keep travelers in the community. Small communities across the country are home to great tourist attractions, fantastic sporting and social events and to many local companies that have regional and even national recognition. These places get visitors on a daily basis and when there is no place to stay, these visitors, stay 30 miles or more away, taking their money with them. They will also not be able to tell their friends and family about the great town they visited last week and all it had to offer. Hotel brands are basically franchises. These brands do not come into a community to build and own the hotel. The property is owned by investors and the brand provides the operating

systems and the reservations systems. Therefore; the challenge is to find investors who might care to have a property in Godfrey.

The advantage of recruiting a national brand is the name recognition and the registration system. Travelers have brands they trust and want to make reservations that will provide rewards for their stay in certain properties. Regional and independent brands cannot compete with the brand equity the national chains.

Potential markets include:

- The proposed hotel would be designed to serve the demographics of 35% corporate with 5% being group; and, 65% leisure with 15% being group.
- Weddings, family reunions and other social events.
- Families visiting residents at Beverly Farm, a home for adults with "developmental disabilities". It was reported that visiting families take residents they are visiting out for several days.
- Vacationers visit the area including the Great River Road and to enjoy the fall colors.
- Corporate/business travelers seek a quality style hotel in the area for employers.
- Participants are in the area for different fishing tournaments.
- Maintenance personnel are in the area for the scheduled shut down at the Phillips 66 Refinery for a couple of weeks.
- Flight crews of planes at the maintenance facility at the nearby St. Louis Regional Airport are reported to be there for a week or more.

Cursory estimated costs for a hotel appropriate for Godfrey range from \$8 to \$10 million. While every deal is different, common arrangements tend to follow something similar to the following:

An investor, or a group of investors, put up 20% to 25% equity on the front end. There is usually an infusion of incentives provided by the community (municipality, county, etc.). The balance of the costs are covered by debt financing, usually through the investor(s).

Mayor Mike McCormick made the official proclamation naming Aug. 29, 2024, "Eric Newby Day" at the Village Board meeting, where he also highlighted Newby's athletic accomplishments.

Eric is a 20-year seasoned veteran on the USA Wheelchair Rugby team and was named co-captain along with Chuck Aoki, of the 2023 squad. Having moved into a leadership role on the team, he is looking forward to helping create a new identity for this USAWR team, which he calls "young, gritty and scrappy."

Along the way, Eric was honored by neighbors and area school students who stood aside the road holding American flags and posters.

Eric Newby is a two-time Paralympian, winning silver medals both in the Tokyo (2020) and in Rio de Janeiro (2016) Paralympic Games, and will be competing on Team USA in the 2024 Paralympic Games in Paris.

Featured Business of the Month: Heritage Farms



As summer comes to a close, those autumn activities are just around the corner. Soon, family activities will turn to apple and pumpkin picking. Hot apple cider and sweaters and jackets will be the order of the day. For those of us in Godfrey, we have a farm right here on Winter Lane where apples and pumpkins can be found in abundance.

Heritage Farm is a family owned and operated business. Patrick and Lindsay Gibson purchased the farm in 2017 and started the business in 2018. They and their three sons Mason (7), Easton (5) and Austin (3) live on the property.

The farm is a bit over 36 acres. Approximately 9 acres are in orchard with 13 varieties of apples. Around two acres is in a nursery where new apple trees are started from bare roots and grafting. Another 20 acres is dedicated to growing 50 different varieties of pumpkins.

About 65% of the farm's trees are sold wholesale, and the balance are retail. Pumpkins are also sold both wholesale and retail.

In 2020, the couple expanded to offering activities on the farm. When visiting the property one will find the trees and the

pumpkins are set up for a "u-pick" experience. There is an area for kid's play and picture taking.

Heritage Farm's owners strive to make visits to the farm fun, relaxing and memorable. Families can look forward to a day enjoying picking, playing and plenty of yummy treats!

Opening day for the 2024 season was September 7. The farm will be open on weekends with the following major events:

- September 15 Apple Fest
- September 22 Spiderman and Cinderella
- September 29 Animals On The Farm (petting zoo and pony rides)
- More events are being planned

At the Apple Festival come ready to pick apples, enjoy inflatables, shop vendors, eat at a food truck and pick up some sweet fall treats! This will be a fun celebration to kick off the fall season. Spider-Man and Cinderella will be there from 11am-2pm to say "hi" and take pictures with the kids.

The kids' play area offers a multitude of fun activities that include: a tall slide with a climbing wall, putt putt golf, swings, corn play tables, pumpkin bowling and so much more!

Heritage Farm does not cut corners to sell more product. Things are done the right way, even if its harder and takes longer to ensure products are of the highest quality.

The couple have complimentary skill sets to operate and manage the farm and its events. Patrick has a degree in horticulture coupled with Lindsey's background in business and management. Patrick and Lindsey's goal is to empower consumers with an experience to a world of variety and flavors. They are committed to bringing heirloom fruits and vegetables to a market currently dominated by a select few choic-

es. Finally, they strive to create an inviting and fun experience when visiting the farm. Each year Heritage Farm works to expand products and service offerings. Future plans include constructing a retail building, and an event facility and develop new products.

It is fairly common to receive requests about available properties or sites for business locations. When these inquiries occur, the lead time for response is usually limited — sometimes a matter of only a few days. Given the importance of a quick reply, it becomes necessary to

identify available property and related information ahead of time.

The type of information requested in these inquiries is:

- the availability of the property,
- the size and type of any of structures,
- utilities.
- Zoning
- whether or not the property is eligible for any business incentives offered by local or state government; and,
- nricing

Godfrey's Office of Economic Development maintains a list of known available properties not on public listings. For example, the list may have properties in which the owner would entertain selling if an opportunity was to arise — but there is no active attempt to sell.

Identifying available properties includes monitoring the websites of local real estate offices, and other platforms that have property listings. It also requires quite a bit of networking and phone calls to property owners in order to identify sites that might be available.

If there is a property that may be available for sale, is zoned for commercial use, and could be considered should an appropriate inquiry be received by the Office of Economic Development, please notify that office. Information about the property will be keep confidential as appropriate.

Don't forget...... Commercial Property Enhancement Grant

Businesses located in the Godfrey Business District are eligible to take advantage of the "Commercial Property Enhancement Grant" program.

Funding: First \$5,000 — maximum grant is 50%; and, \$5,001 and above is 25% of eligible expenses. The grant limit is a maximum of \$20,000 per project.

Eligible Expenses: Significant facade renovations, signage, awnings, doors, windows. Landscaping if it follows Godfrey Ordinance No. 15-2007. Parking lots if brought up to ADA compliance and Village codes. All appropriate permits must be secured.

Ineligible Expenses: Regular repairs and maintenance, demolition, design, permit fees; and expenses incurred or contracted prior to grant approval.

Eligibility Criteria and Conditions: Owners and tenants of properties within Godfrey's Business District (at time of application). The property's primary use must be for commercial use. Tenants must provide written authorization from the property owner for the contemplated improvements and participation in the program. If the tenant or owner who receives grant funding should close, move, or remove work financed with a grant within five years of grant date, repayment of the grant may be required, pro rata for a period of the remaining three-year term. No additional grant funds are available for similar work at same space for a period of at least five years. Application for the grant does require three bids. The grant must be approved prior to commencement of work.



Early voting begins at Godfrey Village Hall on October 21 and goes through November 1
